# Child Safeguarding Protocol Development Workshop

 12 hours

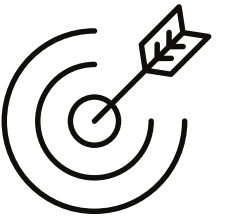
 All staff members, including those who will take on a coordination or supervisory role in developing child safeguarding protocols (focal points).

- ✓ Have created a draft version of a safeguarding policy specific to their organisational setting

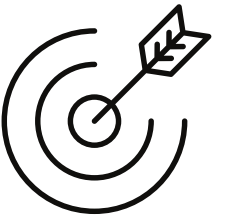
 Field professionals responsible for designing, coordinating, and facilitating child-focused activities in non-formal settings.
